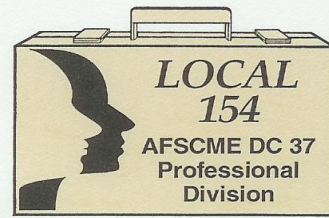

## Salaries for Local 154 Titles in City Agencies and Authorities

Sisters and Brothers:

Pursuant to the Economic Agreement March 2010-July 2017, these are the new salary rates for **newly hired and incumbents** after a 3% increase effective **September 3, 2016**. These amounts do not include additions to the gross such as longevity, service increment, RIPs, differentials, etc.

### DC 37 Economic Agreement effective March 3, 2010 to July 2, 2017:

- **The Agreement includes an Additional Compensation fund of .52% for Additions to the Gross which will be available on March 3, 2017 (it might be used to increase longevitys, RIPs and/or annuities – see Longevitys, RIPs by Title).**
